



- 1) Contractor showed a Total price extension of \$3000.00. Actual calculated Total price extension was \$1500.00.
- 2) Contractor showed a Unit Price of \$1.00 (an obvious mistake or unbalanced Bid), and showed a Total price extension of \$3000.00. \$3000.00 was used in above calculation.
- 3) Contractor showed a Base Bid of \$148,172.00. Calculated Total Base Bid was \$150,672.00.
- 4) Unit Price Dollars & Cents was left blank on all items.
- 5) Contractor left Unit Price Each on these items blank.
- 6) The noted Contractors failed to list Addendum #1 on their Bid Form. This was discussed at the Bid opening and both Contractor's stated they would accept the changes which were defined. Both Contractors had attended the Mandatory Pre-Bid Meeting and visited the City of Hazard maintenance garage where this change was discussed at length.
