

MSD SBE Program Vendor Registration Notification

Dear Small Local Business Enterprise Vendor.

Effective, July 1, 2021, MSD proudly launched our new Small Local Business Enterprise Program Manual (SBE Program), which establishes race- and gender-neutral initiatives, that encourages small, local businesses (SBEs) in Jefferson County and/or Oldham County, Kentucky to actively and competitively bid and participate on MSD contracts. Further, the program is designed to develop, promote and foster inclusiveness, diversification, increase competition, and economic development, as well as ongoing evaluation to assure all small local businesses in MSD service areas are provided equal opportunities in MSD's procurement process to initially compete.

MSD continues to strategically partner with B2Gnow, a diversity management software company, to help support, develop vendor registration, increase operational efficiencies, and essentially further advance our technological data-gathering and tracking, reporting and analytics, compliance management and administrative process automation needs at MSD. B2Gnow also services over 200 cities, counties and other public agencies throughout the nation. Among its many capabilities, the B2Gnow system also includes the following features that benefit the SBE program:

- Automates small business tracking and reporting
- Monitors spending and reduces disparity study costs
- Offers integrated data exchange capabilities
- Tracks outreach program effectiveness

That said, MSD is proud to announce that on *Monday, October 4th, 2021*, our SBE Program registration process was implemented. This affords SBE Program applicants an opportunity to register with MSD, via our electronic portal system, with the support of B2Gnow. The system is accessible to SBEs looking to do business with and become registered in the MSD SBE Program. It provides simplified, cloud-based vendor registration, streamlines online reporting, and is used exclusively for the purpose of registering with MSD as an SBE Program vendor. All new vendor registration applications must be submitted electronically in order to be registered with MSD.

SBE Portal System

You can access the portal by going to the **Supplier Diversity Management System** home page at https://louisvillemsd.diversitysoftware.com/ by clicking "Apply For Registration" under SBE Program Registration for additional information. From there, there are *two main options* to access the system:


New Registration: If your firm is not currently registered with MSD, select "Create Account", and the system will open an registration form to complete.
